PROMOTER

Relationship to you

1. Agrees to use their best efforts to secure a suitable and evenly matched opponent for the Boxer, and at all times to act in the best interests of the Boxer.

Relationship to you

- 2. Agrees to ensure that all contests shall be with approved gloves, which will be stored securely by the Promoter a minimum of 2 days before the contest.
- 3. Agrees that all officials of the contest shall be persons qualified and authorised by the Promoter.
- 4. Agrees to provide the Boxer with all promotional materials for online distribution.
- 5. Provide the Boxer with all food and refreshments on the day of the contest.
- 6. Will make available to the Boxer, a professional hand-wrapping service on the contest day. (Fee to be paid by the Promoter if more that 25 tickets are sold by the Boxer.)
- 7. Agrees to provide the Boxer and his or her fans with an experience like a professional boxing contest.
- 8. Agrees to pay the Boxer a FEE for all ticket sales associated to him or her, as set out below:

a Ticket Sales - 24 or under No Feea Ticket Sales - 25 - 85 10%

b Ticket Sales - 86 plus 20% (all tickets)

c Title Fighter - 25 plus ticket sales 20%

d Sponsorship Packages 10% of package cost

IT IS AGREED THAT

- If the Promoter shall decide that the Boxer did not enter into this contract in good faith, or is not honestly competing, or is guilty of an act that is detrimental to the Promoter or the contest, it is agreed that the Boxer shall not be entitled to the **FEE** or any part thereof, and that such decisions of the Promoter shall be final.
- If the Boxer shall fail to appear, or make the agreed weight, or is not in physical condition to box as determined by the authorised medical representative, or shall fail to sell the minimum ticket requirement, it is agreed that the Boxer shall not be entitled to the **FEE** or any part thereof, and that such decisions of the Promoter shall be final.
- IT IS UNDERSTOOD AND AGREED that this contract is the only contract (written or oral) between the Promoter and the

 Boxer and with respect to the abovementioned contest and that this contract must be given to the Promoter before any match making commences.

BOXER

- 12. Shall take all steps reasonably necessary to prepare himself or herself for the contest.
- 13. Agrees not to take part or engage in any boxing contests or exhibitions unless the Boxer has obtained the written permission of the Promoter to do so.
- Agrees to provide all footage required to promote himself or herself a minimum of 4 weeks prior to the contest, or as soon as possible if this agreement is signed thereafter.
- 15. Agrees to provide social medial handles and agrees to actively promote themselves via social media and offline to maximise exposure to the contest.

16.	Agrees to sell a minimum number of tickets for the contest, as per number 6 above.							
17.	Agrees that the minimum requirement of ticket sales must be met 2 weeks before the contest date in order to be fully accepted on to the contest.							
18.	Agrees to use his or her best endeavours to attend the official face-off as organised by the Promoter. Details of which are:							
Boxer RELE	ASE OF LIABILITY							
19.	The Boxer accepts that in consideration of the participation in the contest, hereby agrees to assume all risks attendant upon himself or herself while participating.							
20.	The Boxer hereby waives, releases, and discharges any and all claims for death, personal injury, or property damage which himself or herself may have, or which may thereafter accrue to himself or herself, as a result of the participation in the contest.							
21.	The Boxer agrees to indemnify and hold harmless from liability the Promoter and/or any of their agents, servants, volunteers, or employees, by reason of any accident, death, injury, or damages, to persons or property which the Boxer may suffer, while participating in the contest.							
22.	This release is intended to discharge the Promoter and/or any of their agents, servants, volunteers, or employees by any reason of any accident, death, injury, or damages to persons or property which I may suffer, from and against any and all liability arising out of or connected in any way with my participation organised by the Promoter, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.							
23.	It is further understood and agreed that this waiver, release, and assumption of risk to be binding on my heirs and assigns of the Boxer.							
24.	The Boxer agrees to assume all responsibilities for any property damage or injury to any person caused by the Boxer while participating in the contest. NG LAW AND JURISDICTION							
25.	This Agreement shall be governed by and interpreted according to the law of England and Wales and all disputes arising under the Agreement (including non-contractual disputes or claims) shall be subject to the exclusive jurisdiction of the English and Welsh courts.							
26.	The Promoter and Boxer agree to fulfil in good faith the terms and conditions of this contract during the period covered by this contract.							
27.	The relationship between Promoter and Boxer is personal in nature and this contract shall be construed as a personal service contract.
